

2026/27 Cancellation Policy:

- Credit card details are required to secure any cabin or tour reservation.
- Any cabin reservation that is cancelled 30 days or more prior to the check in date will have no charge.
- Any cabin reservation that is cancelled less than 30 days prior to the check in date: the amount of your first night stay will be charged to your credit card on file.
- Any cabin reservation that is cancelled 7 days or less prior to the check in date of the reservation (or in the case of a no-show) The full amount of the reservation will be charged.
- The cancellation policy includes **early check-outs or no shows. There will be no refund for early check-outs.** Adding nights to a cabin booking is subject to availability.
- Our tours have a 14 day cancellation policy. Any tour reservation that is cancelled 14 days or less prior to the date of the tour (or in the case of a no-show) The full amount of the tour will be charged.
- In the event of a transportation, weather, health/ family emergency or natural event which restricts you from your reservation, Bella Coola Grizzly Tours **is not responsible** and this policy **will still remain in effect.** We encourage guests to refer to their travel/ credit card insurance for compensation.
- ***Each cabin rate is based on double occupancy, additional guests are \$20.00 per guest per night.** Maximum Capacity limits are set for each cabin based on available beds and cabin space. These capacities are set to ensure comfort during your stay. We ask you respect our set limits, if you have additional guests please reserve another cabin or inquire with Management.
- Please advice at time of booking if you have a pet, **CABIN 3,4,9,10 are NOT PET FRIENDLY. Under no circumstances are pets allowed in those cabins.** We have specific cabins allocated for pets; there is a fee of \$25 per night per pet . No pets are allowed upstairs, on beds or furniture. All pets must never be left unattended in cabins or vehicles. Owners must clean up after their pets bathroom breaks. If your pet is unfriendly with other animals it must be on leash at all times when outside of the cabin. **Any damage by pets to cabin, furniture, property or to other pets will be charged to your credit card.**
- Any damages to the Gazebo, cabins or contents will be charged to the credit card on file
- A fee will be charged for any dirty dishes left upon check out.
- Kitchens are not intended to be used for commercial purposes.
- Cabin renters will not be permitted to set up a tent camp to house more people, unless previous arrangements have been made with the owner.
- Our Tours generally meet minimums required to depart and we do our best to fill them, but Tours are not guaranteed and are always subject to availability, weather and required minimums.
- Under NO circumstances is there to be seafood of any kind processed in the cabins. We kindly ask that all Seafood, shellfish or any fresh or saltwater fish be processed off the property of Bella Coola Grizzly Tours & Resort. We further request all shellfish be cooked / eaten in the Gazebo where it can be cleaned up and disposed of. In the event this policy is not followed there will be an additional cleaning fee and/or a damage fee applied to your credit card on file.
